

FLORIDA CITRUS HALL OF FAME SELECTS INDUCTEES FOR THE CLASS OF 2022

The selection committee for the Florida Citrus Hall of Fame has announced three more distinguished industry leaders and influencers that will be inducted into the prestigious Hall, representing the Class of 2022.

George F. Hamner, Jr. will be the 200th member inducted to the Florida Citrus Hall of Fame, along with the posthumous inductions of A. Tillis Edwards, Jr., and Edward A. Taylor. All three will be honored during the 60th Citrus Celebration Luncheon tentatively scheduled for Friday, Nov. 4, 2022 at Florida Southern College in Lakeland.

Being an Indian River grower, George Hamner has been a workhorse for Florida's fresh segment for 43 years, providing active leadership to the Florida citrus industry by working closely with state and federal agencies to help bridge governmental, regulatory, grower, and shipper communities. He





has successfully led his family's fresh fruit packing business, Indian River Exchange Packers, Inc. through the ups and downs of the industry during the past five decades, while volunteering his time in numerous industry organizations. Hamner has served as President of Florida Citrus Packers, Chairman of Citrus Administrative Committee, board member of New Varieties Development & Management Corp., President of Florida Citrus Mutual, President and Board member of Indian River Citrus League and member of the Florida Citrus Canker Technical Advisory Task Force. He has hosted trade missions, senior state and federal politicians, international regulatory review teams, emergency response investigators, and more to ensure a viable and sustainable industry.

The League is honored to have one of their own honored as the 200th member inducted into the Florida Citrus Hall of Fame. Greg Nelson, President of Bernard Egan & Company stated, "George has consistently displayed great passion for the welfare of the industry, and has worked tirelessly to protect the best interests of the Florida citrus growers." Ron Edwards, President of Evans Properties had similar sentiments, "every time the industry needed someone to lead an important issue George was always there."

The Florida Citrus Hall of Fame honors distinguished leaders who have made significant contributions to the Florida citrus industry. The Citrus Hall of Fame display and Archives Center is located within the Sarah D. and L. Kirk McKay, Jr. Archives Center building at Florida Southern College in Lakeland.
