RIVER GROWERS PARTNER WITH NIFA GRANT

USDA-ARS scientists Drs. Michelle Heck and Randall Niedz were approached by the League about coordinating a meeting with the River growers about a unique approach to testing molecules to combat HLB called Grove First. So, on November 16, 2023, with interested growers in attendance, met with Drs. Michelle Heck and Randall Niedz, to hear about a novel approach to HLB research that bypasses lab assays and test molecules directly in the grove to learn of their ability to solve the HLB situation that has overtaken the citrus industry here in Florida.

Along with Drs. Heck and Niedz, the research team also includes Nick Larson (USDA-ARS) and Guilherme Locatelli and Lorenzo Rossi, cooperators from the University of Florida. Also, providing contributions to this project is Dr. Brian Scully, retired USDA-ARS lab director, who is researching available molecules to test which ones would meet regulatory requirements. So far over 200 molecules have been selected to test.

This unique research is part of a \$15 million USDA's National Institute of Food and Agriculture (NIFA) funded project that aims to solve the citrus greening disease that has overtaken the citrus grower regions of the State of Florida.

- Phase one of this approach is screening a large number of molecules on HLB-infected trees to identify molecules that show horticultural effects equal to or greater than trees treated with OTC.
- Phase two is larger grower trials to test the molecules identified in Phase one.

The partnership with the grower cooperators is the single, most important part of this process to identify the molecules that can solve HLB.

Molecules are tested by injecting into HLB-infected trees using 100 milliliters of a solution containing the molecule using a FlexInject device. Then the effects of the molecules are observed over the next 12 months to determine if the molecules' impact on the tree's health warrant additional field trials.

Drs. Michelle Heck and Randall Niedz are meeting with other Florida citrus organizations in hopes to have additional growers come on board as collaborators.

Doug Bournique, Executive Vice President of the Indian River Citrus League stated, "Michelle and Randy along with Dr. Brian Scully and the team are on a possible breakthrough for our industry and need all the support we can give them."

The queens in attendance dated back to the 1965 Florida Citrus Queen, Karol Kelly Bullard and culminated with the 2023 Miss Florida Citrus, Casana Fink, who would give up her crown later that night in Winter Haven to the Centennial Miss Florida Citrus, Alana Scheuerer, of Coral Springs.

Scheuerer, age 26, of Coral Springs, is a two-time Florida State University graduate, holding a degree in Hospitality Management and Tourism and a Masters in American Dance



Studies. She works in the behavioral health field doing community outreach for the International Association of Firefighters Center of Excellence through Advanced Recovery Systems. Alana's social initiative is TAP: Turn up Artistic Participation. An award-winning tap dancer, Alana started her university's first tap dance team and currently advocates for community involvement in arts. She serves on her city's public art committee and is a regional director for Fly Dance Competition. For her talent during the competition, Alana performed a tap dance to Adele's "Rolling in the Deep."

The following night, a Florida Citrus Queen Centennial Celebration Gala was held at Nora Mayo Hall to welcome the new Miss Florida Citrus. 

ONE STOP GUIDE FOR CITRUS GROWER PROGRAMS

USDA/Farm Service Agency Emergency Relief Program (ERP 2022)

ERP 2022 covers crop production, including certain quality losses, and losses of trees due to qualifying natural disaster events that occurred in calendar year 2022. For impacted producers, FSA will be administering emergency relief to eligible producers through a two-track process:

- **Track 1** will leverage existing Federal Crop Insurance or Noninsured Crop Disaster Assistance Program (NAP) data as the basis for calculating initial payments. This is for all producers that received crop insurance indemnity payment from an event in 2022.
- **Track 2** will be intended to fill additional assistance gaps and cover eligible producers who did not participate in existing risk management programs. This is also for losses in 2022, but the producer can certify either by tax return sales info or "expected vs actual sales."

TREE ASSISTANCE PROGRAM (TAP) FLORIDA CITRUS GREENING

The 2014 Farm Bill makes TAP a permanent disaster program and provides retroactive authority to cover eligible losses back to October 1, 2011 and is administered by the Farm Service Agency (FSA) of the USDA. TAP for greening will cost share on cost of trees, cost planting trees and cost of site preparation.

PROPERTY APPRAISER'S OFFICES

The duties of the Property Appraiser's Office would be administering the AG classification, which would be uniform state-wide. This classification enables the owner or lessee of a property used primarily for bona-fide commercial agricultural purposes to receive a partial or full waiver of ad-valorem taxes. Below are some important reminders related to the classification:

- α. An existing agricultural classification does not guarantee future agricultural classification under new ownership.
- β. Applicants will be required to provide documentation of the business including but not limited to federal tax return, business licenses/registrations, receipts related to buying and selling of animals, insurance supplies, feed, equipment etc. as deemed necessary by the Property Appraiser and as allowed by statute.
- χ . Granting of applications are based upon requirements outlined in Fla. Statute 193.461 and applicants must continue to meet these requirements on an annual basis.
- δ. The addition or removal of the classification will impact any CAPS currently on the property (these include a 10% non-homestead cap and the 3% save our homes cap)
- ε. It is important to note that it is the property owner's responsibility to report a change in use either affecting the entire parcel or a portion of the parcel to the Property Appraiser; records are updated annually.
- Most importantly- reach out early. We are here to assist in the process, but the timely filing of the application (March 1 annually) is an important part of the two-way communication process. Without an application it is difficult to discuss and determine factors that will impact the ability to grant a classification

CITRUS RESEARCH AND FIELD TRIAL PROGRAM

The CRAFT(Citrus Research and Field Trial) program- provides funding for citrus planting, if growers participate in research. Currently, individual growers use a mixed strategy, including a variety of practices to try to combat HLB and ACP. These strategies vary by grower with no reported or scientifically proven results attributable to any given combination of management practices.



Experts identified the need for comprehensive field testing of HLB management practices to evaluate the efficacy of the practices. It was also recommended that there be a centralized database to inform growers and assist HLB researchers to improve HLB management practices. These recommendations were implicit in the *National Academy of Sciences 2018 Report on Citrus Greening*.

ST. JOHNS RIVER WATER MANAGEMENT DISTRICT

Agricultural Cost-Share Program

The St. Johns River Water Management District has an Agricultural Cost-Share Program that works with farmers, growers and ranchers to conserve water and reduce nutrient runoff. The District accepts eligible applications, awards funding contingent with District Governing Board approval and funding availability.

Eligible project types include converting to a lower-quality water source, conserve water and/or reduce nutrient runoff. Cost-share could be up to 75 percent, not to exceed \$250,000 annually, for the engineering, design, construction and implementation costs.

PLUGGING ABANDONED WELLS

The District has a District Abandoned Artesian Well Plugging Program that is designed to assist well owners in complying with state law in properly plugging artesian wells so they no longer allow water to flow to the surface or between aquifer layers. Participation in the District's program is free, provides technical guidance and oversight of licensed well contractors while the well is being permanently plugged.

Eligible wells typically have one or more of the following characteristics:

- Does not have a properly functioning valve or flow control
- Has no present or future beneficial use
- Does not meet current well construction standards
- Is discharging salt water into a drinking water aquifer
